CARE Ratings (Africa) Private Limited places the Issuer Rating of Swan Life Ltd under Credit Watch with Developing Implications.

CARE Ratings (Africa) Private Limited ("CRAF") has taken cognizance of the delay in publishing of financial statements by Swan Life Ltd for the financial year ending 31 December 2023 and for quarters Q1, Q2 and Q3 for the financial year ending 31 December 2024, resulting from challenges being faced due to the first-time implementation of IFRS 17. In the same line, the Financial Services Commission ("FSC") has provided regulatory relief for a further extension of time limit for filing of annual returns.

In the light of the above, CRAF places the Issuer Rating of Swan Life Ltd under Credit Watch with Developing Implications. CRAF will continue to monitor the developments in this regard and will take a view on the rating once the financial statements are published.

Rating Symbols Long / Medium-term Instruments

Symbols	Rating Definition
CARE MAU AAA	Instruments with this rating are considered to have the highest degree of safety regarding timely servicing of financial obligations, in Mauritius. Such instruments carry the lowest credit risk.
CARE MAU AA	Instruments with this rating are considered to have high degree of safety regarding timely servicing of financial obligations, in Mauritius. Such instruments carry very low credit risk.
CARE MAU A	Instruments with this rating are considered to have adequate degree of safety regarding timely servicing of financial obligations, in Mauritius. Such instruments carry low credit risk.
CARE MAU BBB	Instruments with this rating are considered to have moderate degree of safety regarding timely servicing of financial obligations, in Mauritius. Such instruments carry moderate credit risk.
CARE MAU BB	Instruments with this rating are considered to have moderate risk of default regarding timely servicing of financial obligations, in Mauritius.
CARE MAU B	Instruments with this rating are considered to have high risk of default regarding timely servicing of financial obligations, in Mauritius.
